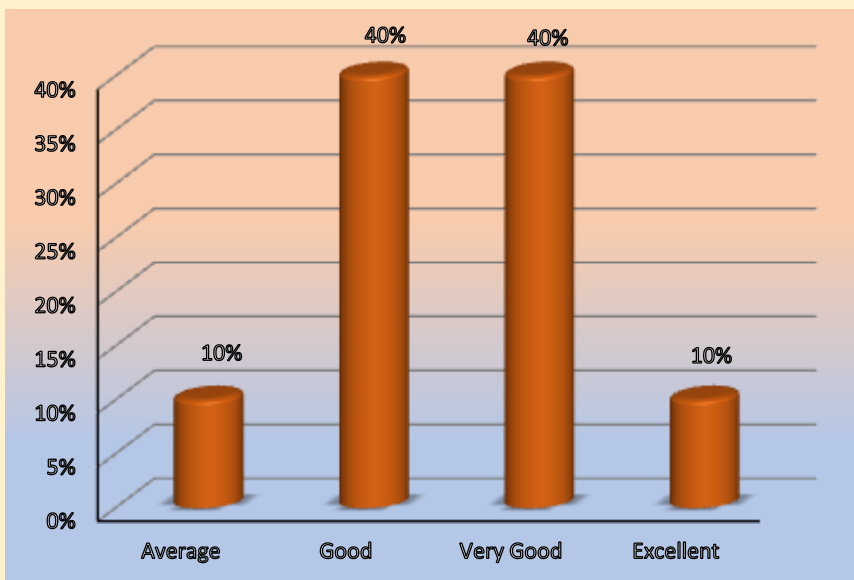
## 1. General discipline of the students

- Encouraged project-based learning where students work in teams to solve real-world problems or develop innovative solutions.



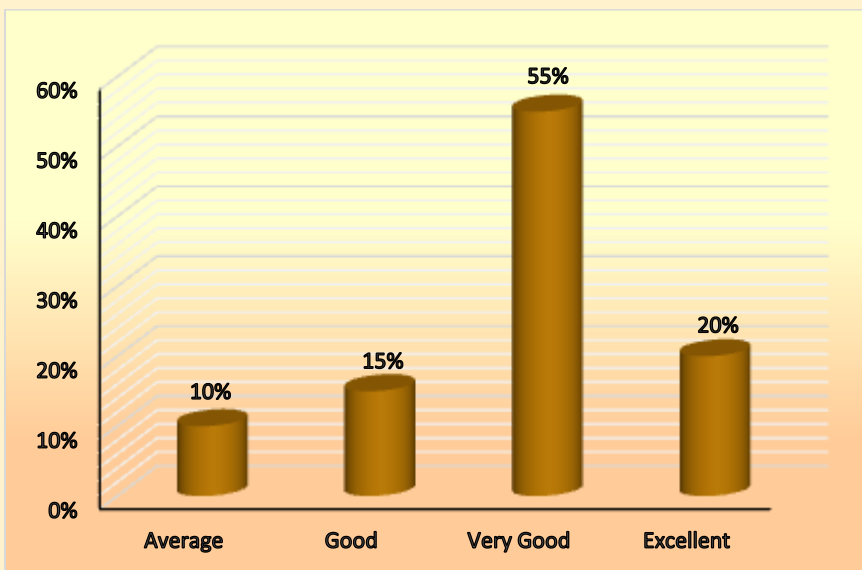
### 3. Classrooms and Lab facilities

### 4. Productive use of software/lab facilities/other digital resources

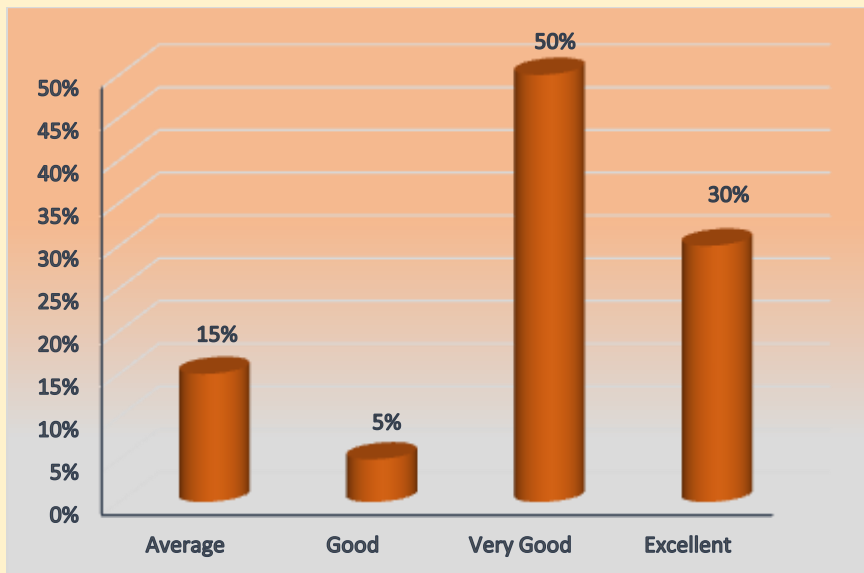


#### Action Taken:

- The college launched awareness campaigns and educational initiatives to promote safety consciousness among the campus community.



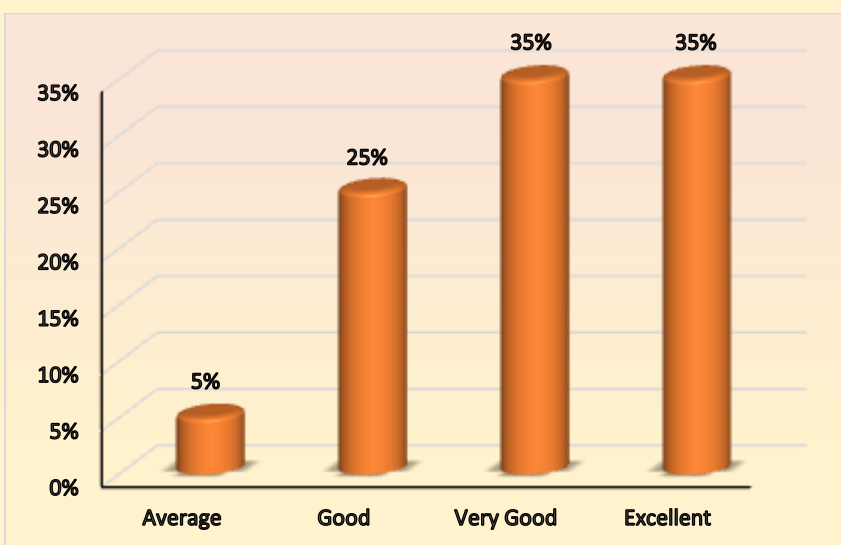
## 7. Professional standards of ethics and integrity

## 8. Encouragements for new approaches and perspectives

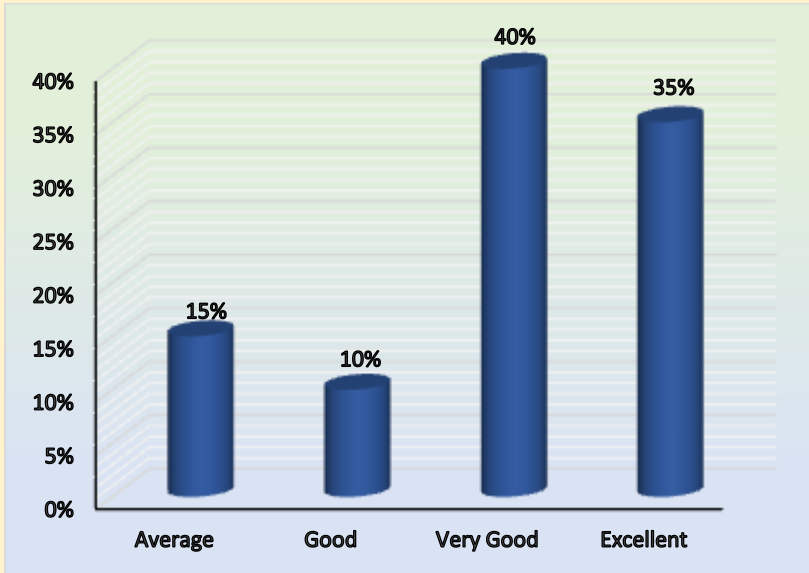


### Action Taken:

- Provided resources and support for innovative projects and initiatives aimed at supporting projects that challenge conventional thinking and bring new perspectives to the table.



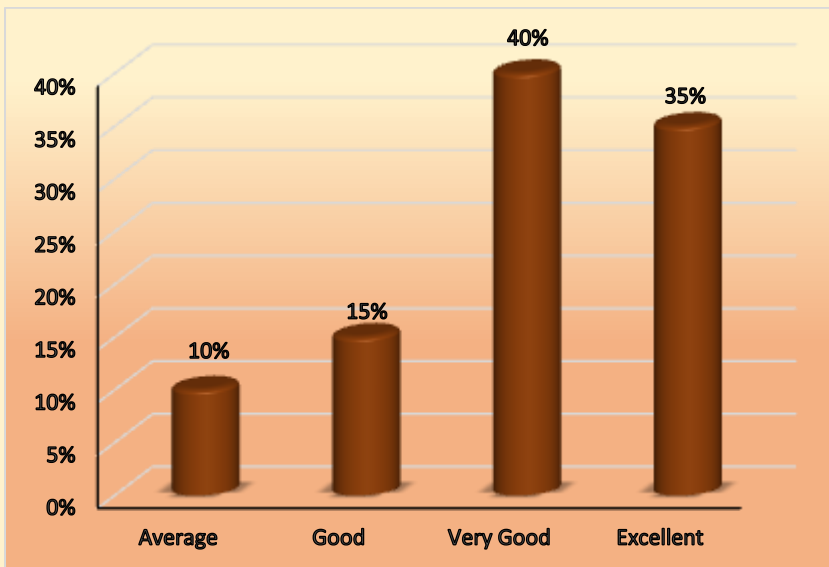
## 9. Overall infrastructure of the College
