The College will abide by the terms & conditions laid down by the University Grants Commission for utilization of the grants.



The Sanction is valid for payment during the financial year 2011-2012.


1. The amount of the Grant shall be drawn by the Under Secretary (Drawing and Disbursing Officer), University Grants Commission on the Grant-in-aid bill and shall be disbursed to and credited to the Principal, Aggarwal College, Ballabgarh, Dist. Faridabad, Haryana-121 004, through Cheque/Demand Draft/Mail transfer.
2. The Grant is subject to the adjustment on the basis of Utilization Certificate in the prescribed Form submitted by the University/College/Institution.
3. The University/College shall maintain proper accounts of the expenditure out of the Grants which shall be utilized only on approved items of expenditure.
4. The Utilization Certificate to the effect the Grants has been utilized for the purpose for which it has been sanctioned shall be furnished to the University Grants Commission as early as possible after the close to the current financial year.
5. The assets acquired wholly or substantially out of University Grants Commission's grants shall not be disposed or encumbered or utilized for the purposes other than those for which the grant was given, without proper sanction of the University Grants Commission and should at any time the College ceased to function, such assets shall revert to the University Grants Commission.
6. A Register of assets acquired wholly or substantially out of the grant shall be maintained by the University / College in the prescribed form.
7. The grantee institution shall ensure the Utilization of grant-in-aid for which it is being sanctioned /paid. In case non-utilization/part utilization, the simple interest as amended from time to time on unutilized amount from the date of drawl to the date of refund as per provisions contained in General Financial Rules of Govt. of India will be charged.
8. The interest earned by the University/College/Institute in this grants in aid shall be treated as an additional grant and may be shown in the U.C./Statement of expenditure to be furnished by grantee institution.
9. The University/College shall follow strictly all the instructions issued by the Government of India from time to time with regard to reservation of posts for Scheduled Castes and Scheduled Tribes.
10. The University/College shall fully implement the Official Language Policy of Union Govt. and comply with the Official Language Act.1963 and Official Languages (use for Official purposes of the Union) Rules, 1976 etc.
11. The sanction issues in exercise of the delegation of powers vide Commission office order no.25/92 dated May, 01, 1992.
12. The University/Institution/College shall strictly follow the UGC regulations on curbing the menace of ragging in higher education's institutions 2009.
