

National Webinar titled “Residential Status & Incidence of Tax”

A National Webinar titled “Residential Status & Incidence of Tax” was organized by the Department of Commerce at Aggarwal College Ballabgarh, Faridabad in collaboration with the ICAI, Faridabad branch on 21st September 2021. Principal Dr. Krishna Kant Gupta was the Chief Guest of the webinar. CA Jitendra Chawla (Chairman, ICAI Faridabad) and CA Nitesh Parashar (Secretary, ICAI Faridabad) were the key speakers. Today’s webinar was organized under the able guidance of our respected Principal sir Dr. Krishna Kant Gupta Ji for the bright future of the students. He spoke about the importance of Taxation Law and the need to pay tax with honesty. In the first session, the keynote speaker CA Jitendra Chawla (Chairman, ICAI Faridabad) presented his views on the topic 'Residential Status & Incidence of Tax'. He started his session in a very interesting way and made a friendly environment with all the participants by asking few basic questions of tax from participants. He highlighted that before levying tax on a person, his residential status is seen and said that without seeing this, his tax cannot be deducted. He spoke that it completely depends on the presence of the person in the country and his residence. He told that in the Income Tax Act, the residential status is divided into 3 parts - Resident and Ordinary Resident, Resident and Not Ordinary Resident, and Non-Resident. The second session's keynote speaker was CA Nitesh Parashar (Secretary, ICAI Faridabad). He spoke on the topic 'Taxation Impact on New Amendments' in residential status of 120 days. He told that the purpose of levying tax was not only to collect money but also to achieve economic and social justice. Equal distribution of wealth in the society to increase production and employment and to achieve economic development of the country. Along with this, the keynote speaker also introduced the students to the importance of CA. He presented his views on the role of CA. The work of CA in any institute is very respectable and challenging. They are responsible for all account and finance-related work related to that institution or company.
